About this Company

Target Rifle South Australia Incorporated is a not-for profit sporting organization. Our sport manages the Olympic and Commonwealth Games disciplines for .22 rifle and .177 Air Rifle in South Australia, and we also support competitive Bench-rest and other forms of .22 target rifle competitive shooting.

We employ several casual employees to assist in the day to day requirements of the sport which includes the management of our sporting equipment shop, and assisting and promoting our sport to visitors attending the range. We also have a number of volunteers who are actively involved with Association activities.

The facility is open Tuesday to Saturday 10.00a.m. – 4.00p.m. and several of our clubs utilize the facility on Tuesday, Wednesday, Friday and Sunday.

Our facility is also used by the SA Rifle Association 4 days a week and by TAFE once or twice a week by arrangement.

The sport is managed by a Management Team, all of whom are full members of the sport and hold their positions on the Management on a voluntary basis.

Our volunteer Range Officials and Coaches are encouraged to attend the courses that are provided from time to time by the Association.
To engage and consult with employees on day-to-day health and safety conditions and provide advice and supervision on occupational health.	All staff	Staff are consulted on health and safety matters as they arise. Staff are also encouraged to come to any of the members of the Management Committee to discuss any concerns or problems.
To implement emergency procedures – evacuation in case of fire or other significant incident.	Management	Escape routes are well signed and kept clear at all times. Evacuation plans are posted in various places around the venue and updated as necessary. Fire blankets, hoses and extinguishers clearly placed around the building. Duress Alarm is in place in the Equipment Shop area.
